1. IF PURCHASING AN EXTRA ENTRÉE, COST WILL REMAIN AT \$1.75
2. MILK ONLY (NOT ORDERING A FULL MEAL) IS NOT FREE – COST IS \$.50 PER CARTON INCLUDING PACK LUNCH BUYERS
3. YOU STILL NEED TO FILL OUT THE MONTHLY ORDER FORM—WE NEED TO KNOW HOW MUCH FOOD TO ORDER AND PREPARE. IT IS HIGHLY RECOMMENDED AND PREFERRED THAT A LUNCH/MILK ORDER FORM BE SUBMITTED MONTHLY.
