From everything we have been hearing, we are expecting a lot of people. If you plan to come, might I suggest that you try to come as early as you can when the number of people is expected to be lower. I highly recommend parking on the street or in the neighborhood or in the school's brick lot after 1:30 p.m. Parking will be limited in the church lot.

There will be our typical 8:05 a.m. Mass that day and there will be an additional Mass at 7 p.m. Veneration will briefly stop during this Mass and begin again when the Mass is over.

I apologize to our school families for the rather last-minute notice for early dismissal. It was unforeseen that we might have as large of crowds as we are now expecting, and our advisors have recommended an early dismissal out of an abundance of caution.

Thank you to our scores of volunteers who will be on hand to make the day run smoothly. If you have not already received an email from Cathy Sivec, please wear black and white and show up fifteen minutes early for instruction in the server's sacristy.

There will continue to be an EF Mass for those in this area at St. Mary Parish at 1 o'clock. There are also EF Masses at St. Elizabeth and St. Stephen in Cleveland.

The final Mass was celebrated here by Fr. David Ireland and was followed by a potluck dinner to honor the servers and thank all of the other people who ministered at this Mass. Then there was the difficult task of figuring out, after thirteen years, what belonged to St. Mary originally, what belongs to St. Sebastian and what had been borrowed from other parishes. I have never "lost" a Mass before, so it was quite a melancholy feeling. For those who will be remaining, thank you for staying a part of the parish. For those who are going to one of the extraordinary form parishes or returning to your home parishes, thank you for your years of involvement and generosity here and know of my prayers for your spiritual journey.

One of our parishioners, Mr. Larry Whitney, of whom Joe Gorman, a founding member of Gorman, Malarcik & Pierce, which was one of Akron's most prominent criminal defense firms said, "If they had a Mount Rushmore for Akron [criminal defense] attorneys, Larry would be on it, wrote this open letter concerning the election on Tuesday.

#### **ISSUE 1**

Those of you who know me personally, know that I have spent over four decades defending individual rights and interpreting statutes in state and federal courts. With that said, aspects of the debate regarding Ohio Issue 1 have bothered me. I want this correspondence to help put the record straight. In sum, there have been TV spots and literature which is, at best, deceitful.

The first is a TV ad where a man states he is Catholic but says that he supports Issue 1 because the current statute is radical and does not provide for exceptions for health of the mother, rape, and incest. That is just not true. The Heartbeat Protection Act, placed on hold by the Ohio Supreme Court, does make an exception in a case of a medical emergency of the pregnant woman. Issue 1 enshrines the right to abortion at any time, including partial birth abortion during any month. The right to abortion becomes a constitutional right; just like the right to jury trial, due process and equal protection; unlike a statute that can be amended by the legislature.

The second ad shows an OB/GYN who states that Issue 1 should pass to protect our children. How are our children protected by making the right to abort a child at any time, regardless of viability. Most of us have put still photos from a scan of our daughter's baby during pregnancy on our fridge. How can anyone, especially an OB/GYN endorse a constitutional amendment who would permit aborting that child, except under extreme conditions (which Ohio's current statute authorizes).

Thirdly, an ad appeared wherein a pastor from a church in Columbus endorsed Issue 1 to protect the family's rights in the abortion decisions. This is as far from the truth as one can get. Issue 1 establishes in the Ohio constitution, an individual's right to "one's own reproductive medical treatment, including but not limited to abortion." I stress that Issue 1 does not limit this individual's right to just abortion. It is purposeful. Issue 1 does not say "any adult" it states, "any individual." A child is an individual. Issue 1's effect could and probably would prohibit parental notification and parental consent in not only abortion decisions but in gender surgery and contraception. This amendment is purposefully inclusive of protection of all "reproductive medical treatment" of all "individuals". Think of the ramifications of Issue 1.

These ads at best are misleading and at worst are deceptive. A Catholic, a pastor and a doctor were chosen to endorse the issue. I doubt whether any of them actually read the language of Issue 1. So, if you are comfortable with abortion up to the ninth month, then you should be comfortable with Issue 1. If you think a child of 14 or 15 should be able to make reproductive decisions like abortion or gender decisions or contraception decisions without input of parents or notification of parents, then you should be comfortable with Issue 1.

Finally, if you are comfortable with granting blanket immunity to any person or entity that provides abortion and any other reproductive services to your child without your knowledge or consent, then you should be comfortable with Issue 1.

Don't take my word for it. Read the text please and VOTE.

The final school paper for the class of 1940 was the only one included in this file for some reason. Perhaps it was because of the dedication on the front page: "WE THE GRADUATING CLASS OF JUNE, 1940 OF ST. SEBASTIAN GRADE SCHOOL DEDICATE THIS, OUR SCHOOL PAPER, TO THE PRIESTS AND NUNS OF OUR PARISH." The first page is entitled, "The Class Will," was followed by a lengthy list of bequeaths that run along the lines of:

Joan Dettling wills her baseball ability to Rosie Humphry
James Coulter wills his colorful sweaters to Sister Fidelma
Mary Lou Knapp wills her merit cards to Ellen Rohnor
Donald Albrecht wills his traffic post to Skip Ball
Pat Motz wills her sister's sweaters back to her.
Phil Ulrich wills his knack of making conversation to Mark Hamlin

The second page is entitled, "CLASS PROPHECY"
