PLEASE CONTINUE TO FILL OUT THE 2020-2021 FREE AND REDUCED SCHOOL MEALS FAMILY APPLICATION FOR WHEN THIS PROVISION EXPIRES. SEPTEMBER PAID LUNCH ORDERS WILL BE REFUNDED. THE FOLLOWING EXCEPTIONS APPLY:

1. IF PURCHASING AN EXTRA ENTRÉE, COST WILL REMAIN AT \$1.75
2. MILK ONLY (NOT BUYING A FULL MEAL) IS NOT FREE – COST IS \$.50 PER CARTON INCLUDING PACK LUNCH BUYERS
3. YOU WILL STILL NEED TO FILL OUT THE MONTHLY ORDER FORM

IF YOU HAVE NOT PREORDERED LUNCH FOR THE MONTH AND NEED A LUNCH FOR THE DAY, STUDENT OR PARENT MUST PLEASE NOTIFY THE OFFICE IN THE MORNING BEFORE 9:00 A.M TO ENSURE ENOUGH FOOD IS PREPARED (IT IS HIGHLY PREFERRED AND RECOMMENDED THAT A LUNCH/MILK ORDER FORM BE SUBMITTED).
